**(Authorizing Acceptance of Use of Phase II: Wireless E911 Implementation Grant from the Public Safety Foundation of America)**

RESOLUTION NO. 03-395

1 WHEREAS, the Department of Information and Technology requests the support of the Tohono  
2 O'odham Legislative Council for the grant proposal for Phase II: Wireless E911 Grant  
3 in the amount of \$89,704 from the Public Safety Foundation of America; and

4 WHEREAS, the term of the grant is for 12 months commencing upon the date of acceptance.

5 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council accepts and  
6 authorizes the use of the provisions of the grant as presented in the attached budget.

7 BE IT FURTHER RESOLVED that the Executive Branch is authorized to expend the funds for the  
8 term of the grant and waive indirect costs.

10 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09<sup>TH</sup> Day  
11 of SEPTEMBER, 2003 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0-  
12 AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by  
13 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
14 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
15 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
16 Stat. 984).


