

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of Pisinemo District FY- 2004 Budget)

RESOLUTION NO. 03-403

1 WHEREAS, at a regularly scheduled session of the Legislative Council, Pisinemo District did
2 present the District Operating Budget for Fiscal Year 2004 in the amount of
3 \$566,229.25; and

4 WHEREAS, the Tohono O'odham Legislative Council did review the proposal of Pisinemo District;
5 and

6 WHEREAS, the Tohono O'odham Legislative Council did determine that there was sufficient
7 funds with the Nation's Distribution of \$430,755.22 and \$135,474.03 from Pisinemo
8 District's Account to support this proposal; and

9 WHEREAS, Pisinemo District Council did approve their FY-2004 Budget through Pisinemo
10 District Council Resolution 2003-20 dated September 2, 2003.

11 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does approve
12 the FY 2004 Operating Budget of the Pisinemo District in the amount of \$566,229.25.

14 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day
15 of SEPTEMBER, 2003 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0-
16 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by
17 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
18 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
19 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
20 Stat. 984).


