**RESOLUTION NO. 03-404**

1 **WHEREAS, the Gu-Vo District Governing Council at their regular meeting on September 09, 2003,**  
2 **did discuss the Fiscal Year (FY) 2001 Supplement Budget; and**  
3 **WHEREAS, the Gu-Vo District Governing Council has determined that it is in the best interest to**  
4 **request of the Tohono O'odham Legislative Council a continuation of FY 2001**  
5 **Supplement Budget; and**  
6 **WHEREAS, the Gu-Vo District Governing Council desires to continue expending funds until the**  
7 **Supplement Budget is exhausted; and**  
8 **WHEREAS, the Gu-Vo District does reserve the right to modify funds as required.**  
9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
10 **approves a continuation of the Gu-Vo District's FY 2001 Supplement Budget through**  
11 **FY 2004.**

13 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup> Day**  
14 **of SEPTEMBER, 2003 at a meeting at which a quorum was present with a vote of 1,887.75 FOR; 466.2**  
15 **AGAINST; 295.75 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
16 **Section 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
17 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
18 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
19 **18, 1934 (48 Stat. 984).**


