

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Adopting Rules of Procedure for Enrollment Revocation Hearings)**

**RESOLUTION NO. 03-406**

1 **WHEREAS, the Legislative Council is vested with the power to "enact laws and ordinances**  
2 **governing . . . the relinquishment and loss of membership" (Constitution of the**  
3 **Tohono O'odham Nation, Article VI, Section 1(h)); and**

4 **WHEREAS, Article IX of the Enrollment Ordinance, Ordinance No. 5-81 (as amended), provides**  
5 **for the loss of membership in the Tohono O'odham Nation on grounds of dual**  
6 **enrollment or when enrollment was based upon incorrect or omitted information;**  
7 **and**

8 **WHEREAS, the Rules Committee, in consultation with the Enrollment Committee, has developed**  
9 **the attached "Rules of Procedure for Enrollment Revocation Hearings" ("Revocation**  
10 **Hearing Rules"), which are incorporated by this reference; and**

11 **WHEREAS, the Revocation Hearing Rules would provide a procedure for the loss of membership**  
12 **based upon dual enrollment or when enrollment was based upon incorrect or**  
13 **omitted information; and**


14 **WHEREAS, the Rules Committee recommends that the Rules of Procedure for Enrollment**  
15 **Revocation Hearings be adopted.**

16 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that the attached**  
17 **Rules of Procedure for Enrollment Revocation Hearings are hereby adopted.**

18 **BE IT FINALLY RESOLVED that all prior resolutions or legislative orders establishing rules of**  
19 **procedure for hearings addressing lost of abandoned membership, including but**  
20 **not limited to Resolution No. 01-129 are hereby rescinded.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup> Day**  
22 **of SEPTEMBER, 2003 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0-**  
23 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
24 **Section 1 (a) & (h) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
25 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
27 **18, 1934 (48 Stat. 984).**
