

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2004 Projected Revenues in the amount of \$39,296,219)**

**RESOLUTION NO. 03-409**

1 **WHEREAS, the Budget & Finance Committee, Chairwoman of the Nation, and the Chief Judge**  
2 **reviewed the revenue projection and available revenues for FY 2004; and**

3 **WHEREAS, the Budget & Finance Committee, Chairwoman of the Nation, and the Chief Judge**  
4 **recommend adoption of FY 2004 revenues projected and available in the amount of**  
5 **\$39,296,219 to fund the Nation's FY 2004 budget for a six-month period based on FY**  
6 **2003 status-quo levels.**

7 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
8 **approves the attached projected revenues in the amount of \$39,296,219 for the**  
9 **purpose of funding the FY 2004 general fund budgets of the Tohono O'odham Nation**  
10 **for a six-month period based on status-quo levels, resulting in budgets funded at no**  
11 **more than one-half of the general fund budget base for FY 2003.**

12 **BE IT FINALLY RESOLVED that this six-month period pertains to budgets under the general fund**  
13 **only and does not include grants & contracts, initiative, capital, or revenue budgets.**

14 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup> Day**  
15 **of SEPTEMBER, 2003 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0-**  
16 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
17 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
18 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
19 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
20 **18, 1934 (48 Stat. 984).**
