RESOLUTION NO. 03-414

1 WHEREAS, the Sells District Chairman presented the Sells District FY 2004 Budget to the Tohono
2 O'odham Legislative Council for review and approval; and

3 WHEREAS, the FY 2004 Budget covers the cost for the District's Administration in the amount of
4 \$732,362.29; and

5 WHEREAS, the Tohono O'odham Legislative Council did review and approve the Sells District
6 Administration Budget.

7 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
8 Sells District FY 2004 Budget in the amount of \$732,362.29.

9 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH Day
10 of SEPTEMBER, 2003 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0-
11 AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by
12 Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
13 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
14 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
15 18, 1934 (48 Stat. 984).
