**RESOLUTION NO. 03-415**

1 **WHEREAS, the Sells District Chairman presented the Cowlic Community Budget Amendment and**  
2 **new Repair & Maintenance Line Item addition to the Tohono O'odham Legislative**  
3 **Council for review and approval; and**

4 **WHEREAS, Cowlic Community's new line item will be "Repair & Maintenance of Buildings;" and**

5 **WHEREAS, the Tohono O'odham Legislative Council did review and approve the Sells District,**  
6 **Cowlic Community Supplemental Budget Amendment #1, Resolution No. CC-03-02**  
7 **and supporting Sells District Council Resolution No. SD-35-02.**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
9 **Sells District, Cowlic Community \$500,000 Supplemental Budget Amendment #1,**  
10 **Resolution No. CC-03-02 with the supporting resolution from the Sells District**  
11 **Council, Resolution No. SD-35-02.**

12 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup> Day**  
13 **of SEPTEMBER, 2003 at a meeting at which a quorum was present with a vote of 2,163.1 FOR; 192.6**  
14 **AGAINST; 274.0 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
15 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
16 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
17 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
18 **18, 1934 (48 Stat. 984).**


