

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Modifying Legislative Order No. 03-027 and Modifying the Gaming Revenue Distribution
Formula Authorized by Resolution No. 94-098)

RESOLUTION NO. 03-418

1 **WHEREAS, by Resolution No. 94-098, the Legislative Council adopted the Gaming Revenue**
2 **Distribution Formula to allocate the revenue paid to the Nation by the Tohono**
3 **O'odham Gaming Authority pursuant to Section 7(d) of the Gaming Authority Charter;**
4 **and**

5 **WHEREAS, by Legislative Order No. 03-027, the Legislative Council tabled for twelve months**
6 **consideration of a modification of the Gaming Revenue Distribution Formula; and**

7 **WHEREAS, it is in the Nation's interest to modify the Gaming Revenue Distribution Formula to**
8 **better meet the current and projected financial needs for its members.**

9 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 10 **1. Legislative Order No. 03-027 is amended from twelve months to six months.**
- 11 **2. Resolution No. 94-098 is amended as follows:**
 - 12 **(a) The first word of ¶ 1(a) is amended from *Fifty* to *Thirty*;**
 - 13 **(b) The parenthetical following the second word of ¶ 1(a) is amended from (50%**
14 **to (30%);**
 - 15 **(c) The third word of ¶ 1 (b) is amended from *fifty* to *seventy*;**
 - 16 **(d) The parenthetical following the fourth word of ¶ 1 (b) is amended from (50%**
17 **to (70%).**
- 18 **3. All other terms of Resolution No. 94-098 not inconsistent with the above-stated**
19 **modifications shall remain effective.**
- 20 **4. A meeting with the three branches of government and the districts shall occur**
21 **within 30 days of the effective date of the Legislative Council Resolution to**
22 **discuss the provisions of the Gaming Formula change and to obtain input in the**
23 **development of recommendations.**
- 24 **5. The Executive Office in conjunction with the Commerce and Budget & Finance**
25 **Committees shall be directed to formulate a report of recommendations within**
26 **60 days of the effective date of the Legislative Council Resolution. This report**
27 **shall include specific criteria and guidelines for administering and utilizing the**
28 **funds in the account established pursuant to ¶ 1 (a) of Resolution No. 94-098 (the**



Gaming Revenue savings account, currently known as the Desert Diamond Savings Trust account). The report of recommendations shall be submitted to the Chairperson of the Nation, the Chairperson of the Legislative Council, the Chief Judge of the Tohono O'odham Judiciary and to the Chairperson of each of the Nation's Districts. Any recommendations must be adopted by action of the Legislative Council before becoming effective.

The foregoing Resolution was presented to the Tohono O'Odham Legislative Council on the 29TH Day of SEPTEMBER, 2003 at a meeting at which a quorum was present, and by a vote of 1,013.8 FOR; 1,424.5 AGAINST; -0- NOT VOTING; and 191.4 [06] ABSENT, failed to pass because it did not receive a majority of the votes cast as required by Section 2 of Article V of the Constitution of the Tohono O'odham Nation.
