

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tabling Consideration of Administrative Plan, Gaming Revenue Distribution Formula
and Funding Package)

LEGISLATIVE ORDER NO. 03-419

1 **WHEREAS, the Tohono O'odham Nation Chairperson and Vice Chairperson submitted to the**
2 **Sells District Council a Draft Document of their Executive Plan, proposal to change**
3 **the Gaming Revenue Distribution Formula and Health Funding package for their**
4 **review and support; and**


5 **WHEREAS, at a September 23, 2003 regularly scheduled meeting, concerns were raised that the**
6 **communities and the general public had not been given ample time to review and**
7 **submit comments on the three proposals; and**

8 **WHEREAS, the Sells District Council requests that the three proposals be tabled to allow**
9 **adequate time for the communities to review and submit their comments.**

10 **NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council hereby**
11 **tables consideration of the proposed Executive Plan, Gaming Revenue Distribution**
12 **Formula and Funding Package pending review by the communities and districts.**

13 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 29TH Day of**
14 **SEPTEMBER, 2003 at a meeting at which a quorum was present with a vote of 1,424.5 FOR; 1,013.8**
15 **AGAINST; -0- NOT VOTING; and 191.4 [06] ABSENT, pursuant to the powers vested in the Council**
16 **by Section 1 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
17 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
18 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
19 **18, 1934 (48 Stat. 984).**
