

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Agriculture Extension budget as part of the 2004 Executive Branch Budget)

RESOLUTION NO. 03-421

1 WHEREAS, the Executive Branch did present its proposed FY 2004 Budgets to the Legislative
2 Council on September 29, 2003; and

3 WHEREAS, a recommendation was made to disapprove/delete the Agriculture Extension budget
4 in the amount of \$139,022.57 from the overall Executive Branch budget; and

5 WHEREAS, it is recommended that the Agriculture Extension budget remain as part of the FY
6 2004 Executive Branch budget.

7 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby
8 approves that the Agriculture Extension Budget remain as part of the proposed
9 Executive Branch FY 2004 budget.

10 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 29TH Day
11 of SEPTEMBER, 2003 at a meeting at which a quorum was present with a vote of 1,718.05 FOR;
12 911.65 AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council
13 by Section 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by
14 the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
15 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
16 18, 1934 (48 Stat. 984).


