

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Amendment to the Executive Branch Fiscal Year 2004 for the Secretary
Position to the Tohono O'odham Youth Services Budget 01-1202)

RESOLUTION NO. 03-422

1 WHEREAS, on September 29, 2003 the Executive Branch has prepared and presented its fiscal
2 year 2004 budget; and

3 WHEREAS, Resolution No. 03-409 mandated that only a six-month period budget would be
4 authorized based on status quo levels of FY 2003; and

5 WHEREAS, Executive Branch Fiscal Year 2004 Budget is for the period beginning October 1, 2003
6 through September 30, 2004; and

7 WHEREAS, the Council did give recommendations and proposals on the Executive Branch FY
8 2004 Budget.

9 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves
10 the amendment that the Secretary Position to the Tohono O'odham Youth Services
11 Budget 01-1202 be reinstated.

12 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 29th Day
13 of SEPTEMBER, 2003 at a meeting at which a quorum was present with a vote of 2,101.95 FOR;
14 182.05 AGAINST; 345.7 NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council
15 by Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by
16 the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
17 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
18 18, 1934 (48 Stat. 984).


