7		Reservation) which are not the obligation of the United States under this (SAWRSA) or						
8		any other Act of Congress"; and						
9	WHEREAS,	the responsibilities of the Advisory Committee related to development of water						
10		resources qualify for funding under SAWRSA Trust Fund.						
11	NOW, THER	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves						
12		the District Advisory Committee budget in the amount of \$121,250 for fiscal year 2004,						
13		in the form attached hereto.						
14	BE IT FINAL	LY RESOLVED that the Legislative Council appropriates the sum of \$121,250 from the						
15		SAWRSA Trust Fund to fund the District Advisory Committee for fiscal year 2004.
