

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving District Water Advisory Committee Budget for Fiscal Year 2004)**

RESOLUTION NO. 03-423

1 **WHEREAS, the Executive Branch has prepared and presented its fiscal year 2004 budget for the**
2 **District Water Advisory Committee in the amount of \$121,250; and**

3 **WHEREAS, under section 309(b) of SAWRSA, the Nation may expend accrued interest and**
4 **dividends on the SAWRSA Trust Fund "for the subjugation of land, development of**
5 **water resources, and the construction, operation, maintenance, and replacement of**
6 **related facilities on the Papago Reservation (now known as the Tohono O'odham**
7 **Reservation) which are not the obligation of the United States under this (SAWRSA) or**
8 **any other Act of Congress"; and**


9 **WHEREAS, the responsibilities of the Advisory Committee related to development of water**
10 **resources qualify for funding under SAWRSA Trust Fund.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
12 **the District Advisory Committee budget in the amount of \$121,250 for fiscal year 2004,**
13 **in the form attached hereto.**

14 **BE IT FINALLY RESOLVED that the Legislative Council appropriates the sum of \$121,250 from the**
15 **SAWRSA Trust Fund to fund the District Advisory Committee for fiscal year 2004.**

16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 29TH Day**
17 **of SEPTEMBER, 2003 at a meeting at which a quorum was present with a vote of 1,997.8 FOR; 631.9**
18 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
19 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
20 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
21 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
22 **18, 1934 (48 Stat. 984).**
