

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Adoption of One-half of the Executive Branch Fiscal Year 2004 Budgets and Appropriating Funds in the Amount of \$18,582,617.40 for a six-month period)**

RESOLUTION NO. 03-424

1 WHEREAS, the Executive Branch has prepared and presented its fiscal year 2004 budget,  
2 attached in summary form as Schedule 1, to the Tohono O'odham Legislative Council;  
3 and

4 WHEREAS, Resolution No. 03-409 mandated that only a six-month period budget would be  
5 authorized based on status quo levels of FY 2003; and

6 WHEREAS, Executive Branch Fiscal Year 2004 Budget is for the period beginning October 1, 2003  
7 through September 30, 2004.

8 NOW, THEREFORE, BE IT RESOLVED that this budget shall fund regular department and program  
9 operations for a six-month period, therefore resulting in one-half of the funding  
10 needs to expire on March 31, 2004.

11 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Executive Branch  
12 Fiscal Year 2004 budget is hereby approved and it does hereby appropriate  
13 \$18,582,617.40 for Executive Branch operations

14 BE IT FINALLY RESOLVED that the Executive Branch is authorized to expend these funds approved  
15 and appropriated pursuant to the budgets attached and referenced in schedule 1, six-  
16 month budget column, for expenditures in accordance with Resolution No. 03-409.

17 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 29<sup>TH</sup> Day  
18 of SEPTEMBER, 2003 at a meeting at which a quorum was present with a vote of 2,080.95 FOR;  
19 548.75 AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council  
20 by Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by  
21 the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
22 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
23 18, 1934 (48 Stat. 984).
