

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the FY 2004 Solid Waste Management Program Revenue Budget**  
**in the amount of \$494,591.91)**

**RESOLUTION NO. 03-430**

1 WHEREAS, the Solid Waste Management Program is authorized through the Tohono O'odham  
2 Nation's adopted Solid Waste Management Code and Plan to collect fees with which  
3 to supplement its operational and capital equipment requirements; and

4 WHEREAS, the Executive Branch has developed and presented a budget to use fees collected to  
5 assist in the Solid Waste Management Program's operational and Capital  
6 requirements for the coming Fiscal Year 2004, attached and incorporated by  
7 reference; and

8 WHEREAS, sufficient fees have been collected and are on deposit with the Nation to fund the  
9 budget as presented.

10 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves  
11 and authorizes the expenditures of the attached Solid Waste Management Program's  
12 FY 2004 Budget in the amount of \$494,591.91.

13 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 29<sup>TH</sup> Day  
14 of SEPTEMBER, 2003 at a meeting at which a quorum was present with a vote of 1,997.8 FOR; 631.9  
15 AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by  
16 Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the  
17 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
18 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
19 18, 1934 (48 Stat. 984).


