

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Cultural Affairs FY 2004 Dedicated Revenue Account Budget)**

RESOLUTION NO. 03-431

1 **WHEREAS, the Tohono O'odham Nation recognizes the need to protect, preserve and manage**
2 **cultural resources on its land; and**

3 **WHEREAS, the Tohono O'odham Nation passed an Archaeological Resources Protection**
4 **Ordinance (06-84) for the protection and preservation of archaeological resources**
5 **historically associated with traditional or sacred values and beliefs important to the**
6 **O'odham, and of the physical site, location or context in which archaeological**
7 **resources are found; and**

8 **WHEREAS, the Tohono O'odham Legislative Council established the Cultural Affairs Program in**
9 **1997; and**


10 **WHEREAS, Tohono O'odham Legislative Council Resolution No. 2002-240 established the**
11 **Cultural Affairs Dedicated Revenue Account (Account # 44-1506 411) for the deposit**
12 **of funds received by the Cultural Affairs Program from outside sources and**
13 **authorized the Cultural Affairs Program to expend these funds for operational**
14 **purposes consistent with approved budgets.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
16 **authorizes the Cultural Affairs Program to expend \$5,588 in its dedicated revenue**
17 **account as itemized in the attached FY 2004 Budget.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 29TH Day**
19 **of SEPTEMBER, 2003 at a meeting at which a quorum was present with a vote of 2,080.95 FOR;**
20 **548.75 AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council**
21 **by Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**
22 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
24 **18, 1934 (48 Stat. 984).**


