

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Wildlife & Vegetation Management FY 2004 Dedicated Revenue Account Budget)

RESOLUTION NO. 03-432

1 WHEREAS, the Tohono O'odham Legislative Council Resolution No. 2000-276 established the
2 Wildlife & Vegetation Management Program within the Natural Resources
3 Department; and

4 WHEREAS, one of the stated objectives of the Wildlife & Vegetation Management Program is to
5 "seek funding from outside sources to enhance its ability to meet its goals and reduce
6 the Nation's financial commitment for its operation"; and

7 WHEREAS, the Tohono O'odham Legislative Council Resolution No. 2000-277 established a
8 Dedicated Revenue Account for the deposit of funds received by the Wildlife &
9 Vegetation Management Program from outside sources and authorized the Program
10 to expend these funds for operational purposes consistent with approved budgets.

11 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby
12 authorizes the Wildlife & Vegetation Management Program to expend \$36,250.00 in
13 its Dedicated Revenue Account as itemized in the attached budget.

14 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 29TH Day
15 of SEPTEMBER, 2003 at a meeting at which a quorum was present with a vote of 1,678.4 FOR; 758.7
16 AGAINST; 192.6 NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by
17 Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
18 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
19 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
20 18, 1934 (48 Stat. 984).


