

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2004 Capital Project Budgets and Authorizing Expenditures for
Cultural Center/ Museum and Housing Rehabilitation)

RESOLUTION NO. 03-437

1 **WHEREAS, the Tohono O'odham Legislative Council has authorized Cultural Center/ Museum**
2 **and Housing Rehabilitation as Capital Projects and have appropriated funds held in**
3 **reserve for each respective project; and**

4 **WHEREAS, the Executive Branch has prepared and presented FY 2004 budgets for the projects**
5 **as summarized in the attached Schedule 6 which is incorporated into this resolution**
6 **by its reference providing for \$5,108,858.49 for Cultural Center/ Museum,**
7 **\$1,578,702.44 for Housing Rehabilitation Operations and \$4,270,019.00 for Housing**
8 **Rehabilitation Construction; and**

9 **WHEREAS, the schedule presents funding allocation for Special Projects which is addressed**
10 **separately; and**

11 **WHEREAS, sufficient funds exist to fund the budgets as presented for \$5,108,858.49 for Cultural**
12 **Center/Museum, \$1,578,702.44 for Housing Rehabilitation Operations and**
13 **\$4,270,019.00 for Housing Rehabilitation Construction.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
15 **authorizes \$5,108,858.49 for Cultural Center/ Museum, \$1,578,702.44 for Housing**
16 **Rehabilitation Operations and \$4,270,019.00 for Housing Rehabilitation Construction**
17 **for the FY 2004 budgets presented and summarized in the attached Schedule 6.**

18 **BE IT FINALLY RESOLVED that the Executive Branch is further authorized to expend funds from**
19 **the established reserves according to the budgets presented and approved.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30TH Day**
21 **of SEPTEMBER, 2003 at a meeting at which a quorum was present with a vote of 1,636.1 FOR; 993.6**
22 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
23 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
24 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
26 **18, 1934 (48 Stat. 984).**
