

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the Application and Acceptance of the Grant Award for the FY2004 Indian Environmental General Assistance Program (GAP) Grant)

RESOLUTION NO. 03-440

1 **WHEREAS, article XVIII of the Constitution of the Tohono O'odham Nation sets out the Council's**
2 **continuing responsibility to assure for all members safe and healthful surroundings;**
3 **and**

4 **WHEREAS, the Tohono O'odham Nation has taken steps to protect its members and its**
5 **environment by applying for and receiving grant funds from the United States**
6 **Environmental Protection Agency (USEPA) under the Indian Environmental General**
7 **Assistance Program (GAP) and other programs; and**

8 **WHEREAS, the General Assistance Program is tasked with building the Nation's environmental**
9 **protection capacity and infrastructure; and**

10 **WHEREAS, the USEPA has reserved \$275,000 for the second year of a new 4-year cycle of GAP**
11 **funding that will extend from August 1, 2002 through July 31, 2006.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
13 **approves the application for \$275,000 from the USEPA for the General Assistance**
14 **Program.**

15 **BE IT FURTHER RESOLVED by the Tohono O'odham Nation Legislative Council that the Tohono**
16 **O'odham Nation's Official, to wit: the Chairwoman, Vice Chairman and any**
17 **designated official are hereby authorized to negotiate and execute the grant,**
18 **provided however, that any amendments affecting the funding for funding levels of**
19 **the grant shall be submitted for further prior approval.**


20 **BE IT FINALLY RESOLVED that the TONEPA GAP program is authorized to expend funds from this**
21 **grant in the amount of \$275,000 beginning on October 1, 2003 through the grant**
22 **period, which commenced August 1, 2002 and runs through July 31, 2006.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30TH. Day**
25 **of SEPTEMBER, 2003 at a meeting at which a quorum was present with a vote of 1,997.8 FOR; 631.9**
26 **AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**
27 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
28 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
29 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
30 **Stat. 984).**




