

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY-2004 United States Department of Agriculture Food Distribution Program Budget)**

RESOLUTION NO. 03-442

1 WHEREAS, the Tohono O'odham Nation has historically contracted the Food Distribution
2 Program from the United States Department of Agriculture (USDA) to assist eligible
3 families with commodity foods; and

4 WHEREAS, the Executive Branch developed and obtained committee approval of the Food
5 Distribution Budget in the amount of \$158,475.94 + \$26,465.48 (IDC) = \$184,941.42.

6 NOW, THEREFORE, BE IT RESOLVED that the Executive Branch is hereby authorized to expend
7 funds for the Food Distribution Program in the amount of \$184,941.42 effective
8 October 01, 2003 through September 30, 2004.

9 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30TH Day
10 of SEPTEMBER, 2003 at a meeting at which a quorum was present with a vote of 2,164.1 FOR; -0-
11 AGAINST; 465.6 NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by
12 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
13 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
14 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
15 Stat. 984).
