

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(FY 2004 Department of Health and Human Services Budgets)**

**RESOLUTION NO. 03-443**

- 1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**  
2 **Department of Health and Human Services; and**
- 3 **WHEREAS, the Tohono O'odham Nation has operated and wishes to continue operating a Child**  
4 **Care Program to provide child care services to its young tribal members; and**
- 5 **WHEREAS, the Tohono O'odham Nation has operated and wishes to continue operating a Head**  
6 **Start Program to provide educational, health, mental health and parent involvement**  
7 **services to children, three to five years of age; and**
- 8 **WHEREAS, the Tohono O'odham Nation has operated and wishes to continue operating a Child**  
9 **Welfare Services Program to promote safe and stable families and to provide child**  
10 **welfare services; and**
- 11 **WHEREAS, the Legislative Council has approved Resolution No. 03-400 "FY-2004 Head Start Grant**  
12 **Application with a 20% Tribal Match" however approval from the Tohono O'odham**  
13 **Legislative Council to expend the funds awarded is necessary; and**
- 14 **WHEREAS, the Title-B, Subparts 1 & 2 require a 25% match, which the Nation matches through**  
15 **the P.L 93-638 master contract, specifically the Family Preservation Program, as**  
16 **authorized by P.L. 93-638; and**
- 17 **WHEREAS, the Executive Branch developed and obtained committee approval of the following**  
18 **budgets as attached and incorporated by this reference, to be effective October 01,**  
19 **2003 through September 30, 2004 and request authorization to expend funds:**
- 20       **1. FY 2004 CCDF Mandatory Administration - \$58,425.61 + \$9,757.08 (IDC)=**  
21               **\$68,182.69.**
- 22       **2. FY 2004 CCDF Mandatory Program - \$487,389.41 + \$37,164.90 (IDC)= \$526,554.31.**
- 23       **3. FY 2004 CCDF Discretionary Administration - \$71,539.43 + \$11,947.08 (IDC)=**  
24               **\$83,486.51.**
- 25       **4. FY 2004 CCDF Discretionary Program - \$266,205.22 + \$22,194.27 (IDC)=**  
26               **\$288,399.49.**
- 27       **5. Head Start Program - \$1,261,399.32 + \$207,313.69 (IDC) = \$1,468,713.01.**
- 28       **6. Head Start Administration - \$75,395.02 + \$12,590.97 (IDC) = \$87,985.99.**

3. FY 2004 CCDF Discretionary Administration - \$71,539.43 + \$11,947.08 (IDC) = \$83,486.51.
4. FY 2004 CCDF Discretionary Program - \$266,205.22 + \$22,194.27 (IDC) = \$288,399.49.
5. Head Start Program - \$1,261,399.32 + \$207,313.69 (IDC) = \$1,468,713.01.
6. Head Start Administration - \$75,395.02 + \$12,590.97 (IDC) = \$87,985.99.
