

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Supporting the No Cost Extension of Carry over Funds from Fiscal Year 2003 for Vocational Rehabilitation Services for American Indian with Disabilities 121 Project)

RESOLUTION NO. 03-444

1 **WHEREAS, the Tohono O'odham Legislative Council recognizes the need for vocational**
2 **rehabilitation services to enhance the quality of life for people with disabilities on the**
3 **Nation; and**

4 **WHEREAS, the Tohono O'odham Legislative Council is committed to enhancing the level of**
5 **service to members of the Tohono O'odham Nation who, due to a disability, may face**
6 **additional challenges in obtaining and maintaining employment; and**

7 **WHEREAS, the Tohono O'odham Education Department submits this No Cost Extension of Carry**
8 **Forward Funds from FY 2003 Grant Award H250G0980011-00 to be carried over to FY**
9 **2004 from October 01, 2003 to September 30, 2004 for one year at the estimated sum**
10 **of \$409,802.33 at no cost to the funding agency, Rehabilitation Services**
11 **Administration (RSA) which will assist enrolled Tohono O'odham members with**
12 **disabilities living on or near the Nation, and other federally recognized Native**
13 **Americans with disabilities living on the Nation to develop and maintain meaningful**
14 **employment.**

15 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it supports**
16 **the Education Department's No Cost Extension Carry Over Funds from October 1, 2003**
17 **to September 30, 2004 at no cost to the funding agency, Rehabilitation Services**
18 **Administration (RSA), funding the Tohono O'odham Nation Program in the amount**
19 **of \$409,802.33 and authorizes the Chairwoman of the Tohono O'odham Nation to sign**
20 **the No Cost Extension of Carry Over funds and submit the necessary documents and**
21 **assurances to accompany the letter of request for a No Cost Extension of Carry Over**
22 **Funds.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30TH Day**
24 **of SEPTEMBER, 2003 at a meeting at which a quorum was present with a vote of 2,164.1 FOR; -0-**
25 **AGAINST; 465.6 NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
26 **Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
27 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
28 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
29 **Stat. 984).**
