RESOLUTION NO. 03-445

1 **WHEREAS, Water Resources Study Program (WRSP) of the Natural Resources Department has**
2 **accumulated savings in fiscal year 2003 funding provided by the Nation's, TOUA, and**
3 **WRSP MOA with IHS, in the amount of \$17,086.98; and**

4 **WHEREAS, the Water Resources Study Program IHS budget and MOA was approved under**
5 **Resolution No. 01-313 and now has proposed a budget in fiscal year 2004 in the**
6 **amount of \$17,086.98 for its budget line items for salaries and capital expenditure;**
7 **and**


8 **WHEREAS, this budget and its savings proposal has been reviewed by the Water Resources**
9 **Committee and the Budget and Finance Committee and it is recommended for**
10 **approval by the Legislative Council.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council authorizes the**
12 **carryover of savings of IHS funds provided by the Nation's MOA with IHS, for the Water**
13 **Resources Study Program in the total amount of \$17,086.98.**


14 **BE IT FINALLY RESOLVED that the total budget funding for fiscal year 2004 of \$17,086.98 for the**
15 **Water Resources Study Program is approved in accordance with the budget attached**
16 **hereto.**

20 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
21 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
22 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
23 **Stat. 984).**
