

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approval of FY 2004 Department of Human Services - Division of Health**  
**Transportation Service 3rd Party Revenue Budget)**

RESOLUTION NO. 03-447

1 WHEREAS, the Tohono O'odham Nation continues to provide medically necessary transportation  
2 to members and residents of the Nation, collecting 3rd party reimbursements where  
3 applicable; and

4 WHEREAS, there is a need to budget 3rd party revenue funds in the amount of \$363,110.20 to  
5 supplement the operational costs of Health Transportation Service Division; and

6 WHEREAS, the Legislative Council, through resolution # 2000-258 approved that all 3rd party  
7 reimbursement funds obtained by the Division of Health Transportation Service be  
8 applied to the program's base budget and utilized for program operations; and

9 WHEREAS, the Division of Health Transportation Service has sufficient funds deposited with the  
10 Nation's Accounting Department to cover the proposed budget amount of  
11 \$363,110.20; and

12 WHEREAS, a 3rd party revenue budget for FY 2004 has been submitted for review and approval  
13 by the Department of Human Services for the Division of Health Transportation  
14 Service.

15 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby  
16 approves:

- 17 1. The attached 3rd party revenue budget in the amount of \$ 363,110.20 as  
18 submitted to supplement the FY 2004 Health Transportation Service Base  
19 Budget.
- 20 2. The Tohono O'odham Nation Officials, to wit, the Chairwoman and Vice  
21 Chairman or any designated official is hereby authorized to negotiate and  
22 execute contracts and to expend funds associated with this budget.

23 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30<sup>TH</sup> Day  
24 of SEPTEMBER, 2003 at a meeting at which a quorum was present with a vote of 2,080.95 FOR;  
25 548.75 AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council  
26 by Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by  
27 the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
28 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
29 18, 1934 (48 Stat. 984).
