

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving and Authorizing Fiscal Year 2004 Budgets for the Economic
Development Business Grants and Recreation Center Construction)

RESOLUTION NO. 03-448

- 1 **WHEREAS, Initiative IN-01-97 authorized the establishment of reserves to fund the activities**
2 **required under the provisions of the Initiative; and**
- 3 **WHEREAS, of the previously authorized Economic Development Business Grant program of**
4 **\$3,500,000.00, \$2,059,161.08, is estimated to remain unexpended at FY 2003 year end;**
5 **and**
- 6 **WHEREAS, the authorization for the unexpended balance of \$2,059,161.08 will expire on**
7 **September 30, 2003, it is the intent of the Executive Branch to re-authorize these**
8 **funds as a part of its FY 2004 budget of \$3,500,000; and**
- 9 **WHEREAS, the proposed Economic Development Business Grant program of \$3,500,000.00**
10 **requires an additional appropriation of \$1,440,838.92, as presented in the attached**
11 **Schedule 2; and**
- 12 **WHEREAS, the Executive Branch has developed a budget, in the amount of \$14,501,632.47, to**
13 **allocate funds for the design and construction of Youth Centers within various**
14 **districts; and**
- 15 **WHEREAS, the Recreation Construction has an estimated unexpended balance of \$14,728,780.23**
16 **which will expire on September 30, 2003 and is sufficient to cover the requested**
17 **budget for FY 2004; and**
- 18 **WHEREAS, it is the intent of the Executive Branch to re-authorize these funds to be expended as**
19 **proposed in the Recreation Construction FY 2004 budget presented and summarized**
20 **in the attached Schedule 2.**
- 21 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
22 **authorizes an additional \$1,440,838.92 from the Economic Development Grant**
23 **Reserve and re-authorizes the unexpended balance of the FY 2003 budget,**
24 **\$2,059,161.08, for Economic Development Business Grant for a total authorized**
25 **amount of \$3,500,000 for FY 2004 as presented in Schedule 2 attached.**
- 26 **BE IT FURTHER RESOLVED that \$14,501,632.47 is hereby re-authorize from the Youth Center**
27 **Project Reserve for the Recreation Center Construction FY 2004 budget as presented**
28 **in Schedule 2 attached.**
- 29 **BE IT FINALLY RESOLVED that the Executive Branch is authorized to expend funds pursuant to the**
30 **attached budgets presented.**
