

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval for Request for Extension of Time and Authorization to Expend Funds
for FY 2004 on Bureau of Reclamation Grant Agreement No. 6-FG-32-00100 for
Schuk Toak New Farm Development)**

RESOLUTION NO. 03-450

1 **WHEREAS, the Tohono O'Odham Nation entered into a Public Law 93-638 Grant Agreement with**
2 **the Bureau of Reclamation, Agreement No. 6-FG-32-00100, for the construction of a**
3 **distribution system for delivery of Central Arizona Project Water to the Schuk Toak**
4 **District of the Tohono O'Odham Nation in December 1995; and**

5 **WHEREAS, the current expiration date of the Grant Agreement 6-FG-32-00100 is September 30,**
6 **2003, and the construction and the management work now scheduled cannot be**
7 **completed within the time remaining; and**

8 **WHEREAS, the Water Projects Office has assessed the work in progress and funds remaining, and**
9 **has recommended to the Legislative Council that the Grant Agreement be extended for**
10 **an additional year so as to expire on September 30, 2004, and include the budget for**
11 **FY 2004 as attached and incorporated by this reference; and**

12 **WHEREAS, the work remaining under the Grant Agreement for construction and close-out**
13 **activities can be accomplished, under the assumption that funding and processing**
14 **activities are completed in a timely manner throughout the Fiscal Year 2004; and**

15 **WHEREAS, the Water Projects Office has presented this matter to the appropriate committees and**
16 **the committees wish to bring it before the Legislative Council.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby proposes**
18 **a one-year extension of Grant Agreement 6-FG-32-00100 with the Bureau of**
19 **Reclamation from October 1, 2003 through September 30, 2004, in order to complete**
20 **activities related to construction and close-out.**

21 **BE IT FURTHER RESOLVED that the FY 2004 budget in the amount of \$504,565.19 for the one-year**
22 **extension of Grant Agreement 6-FG-32-00100 as attached hereto and incorporated by**
23 **this reference, and that the Water Projects Office is authorized to expend funds in**
24 **accordance with this budget.**

25 **BE IT FINALLY RESOLVED that the Chairman of the Nation is hereby authorized and directed to**
26 **execute a one-year extension of BOR Grant Agreement 6-FG-32-00100.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30TH Day**
28 **of SEPTEMBER, 2003 at a meeting at which a quorum was present with a vote of 2,080.95 FOR; -0-**
29 **AGAINST; 548.75 NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
30 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
31 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
32 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
33 **Stat. 984).**






