7		30, 2003; and
8	WHEREAS,	the Water Projects Office has already purchased the heavy equipment including the
9		motor grader, backhoe loader, spider sprayer, and two (2) vehicles; and
10	WHEREAS,	the Water Projects Office has equipment that can be purchased now that the farm
11		maintenance facility is complete using carry-over funds from the existing Agreement;
12		and
13	WHEREAS,	the Water Projects Office is recommending an extension of the Agreement for an
14		additional three months until December 31, 2003; and
15	WHEREAS,	the Water Projects Office is submitting a budget to expend funds for the remaining
16		equipment needed for Schuk Toak Farm in the amount of \$52,064.10; and
17	WHEREAS,	the Water Projects Office has presented this request and budget to the appropriate
18		oversight committees and is recommended for approval.
19	NOW, THER	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves an
20		extension of Bureau of Reclamation Grant Agreement No. 01-NA-32-00200 for an
21		additional three months until December 31, 2003, and grants authorization to the
22		Water Projects Office to expend funds of \$52,064.10 to purchase the remaining
23		equipment as attached and incorporated by this reference.
