8		the Judiciary budget to a total for FY 2004, only, at \$4,746,357.51; and
9	WHEREAS,	the Judiciary Committee and the Budget and Finance Committee of the Legislative
10		Council of Tohono O'odham Nation have reviewed this budget and recommends its
11		approval and adoption.

13		has reviewed and approved the Fiscal Year 2004 budget submitted by the Judicial
14		Branch.
