

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2004 Legislative Branch Budget)

RESOLUTION NO. 03-458

1 **WHEREAS, the Legislative Branch has prepared and submitted for review and approval of its FY**
2 **2004 Budget; and**
3 **WHEREAS, Resolution No. 2003-409 mandated that only a six-month period budget would be**
4 **authorized based on status quo levels of FY 2003; and**
5 **WHEREAS, the Legislative Council has reviewed the FY 2004 Legislative Branch Budget.**
6 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
7 **the FY 2004 Legislative Branch Budget in the amount of \$1,139,400.00**
8 **BE IT FURTHER RESOLVED that funds in the amount of \$1,139,400.00 are appropriated and**
9 **authorized to be expended from sources of funding approved by this Council for**
10 **support of the FY 2004 budgets of the Tohono O'odham Nation.**
11 **BE IT FURTHER RESOLVED that this budget shall fund the Legislative Branch for a six-month**
12 **period, therefore resulting in one-half of the funding which will expire on March 31,**
13 **2004.**
14 **BE IT FINALLY RESOLVED that the six month period FY 2004 Budget is effective October 01, 2003.**
15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30TH Day**
16 **of SEPTEMBER, 2003 at a meeting at which a quorum was present with a vote of 1,982.05 FOR;**
17 **182.05 AGAINST; 465.6 NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council**
18 **by Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**
19 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
20 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
21 **18, 1934 (48 Stat. 984).**


