

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Adopting Tohono O'odham Legislative Council Committee Meeting Schedule
thru May 2005)

LEGISLATIVE ORDER NO. 03-472

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "establish rules**
2 **and procedures to regulate all meetings of the Tohono O'odham Council" pursuant**
3 **to Section 1(a) of Article VI of the Constitution of the Tohono O'odham Nation; and**

4 **WHEREAS, the Rules Committee has been charged with developing the Legislative Council**
5 **Committee Meeting Schedule for the 2003 - 2005 Legislative Session; and**

6 **WHEREAS, the Rules Committee, in accordance with the newly-established committee**
7 **membership, developed a Tohono O'odham Legislative Council Committee Meeting**
8 **Schedule during the June 2003 General Session adopted as Legislative Order No. 03-**
9 **294 which has since expired; and**

10 **WHEREAS, the Rules Committee, in accordance with the Legislative Rules, developed a second**
11 **Tentative Tohono O'odham Legislative Council Committee Meeting Schedule for July**
12 **07, 2003 - October 2003 General Session which will expire; and**

13 **WHEREAS, the Rules Committee has developed and presented a final Tohono O'odham**
14 **Legislative Council Committee Meeting Schedule for the remaining two years of**
15 **General Sessions and which will expire May 03, 2005 General Session.**

16 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it hereby**
17 **adopts the "Tohono O'odham Legislative Council Committee Meeting Schedule thru**
18 **May 2005" as presented by the Rules Committee.**

19 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 07TH Day of**
20 **OCTOBER 2003 at a meeting at which a quorum was present with a vote of 2,200.0 FOR; 253.6**
21 **AGAINST; 176.1 NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
22 **Section 1 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
23 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
25 **18, 1934 (48 Stat. 984).**
