

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Support for submitting a Grant Application to the Center for Disease Control to
Prevent Motor Vehicle Injuries)**

RESOLUTION NO. 03-473

1 WHEREAS, prevention of injuries is a health priority for the Tohono O'odham Nation; and
2 WHEREAS, the prevalence of motor vehicle injuries and mortality are very high on the Tohono
3 O'odham Nation; and
4 WHEREAS, the Tohono O'odham Department Of Human Services and the Tohono O'odham
5 Police Department and Indian Health Services are currently collaborating to prevent
6 motor vehicle injuries.
7 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby supports
8 the submission of a Grant Application to the Centers for Disease control to Prevent
9 Motor Vehicle Injuries.
10 BE IT FURTHER RESOLVED that any data and education materials generated by this project will
11 be the sole property of the Tohono O'odham Nation.
12 BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council and the Tohono O'odham
13 Nations Officials to wit: the Chairwoman and any designated official are approved to
14 submit an application to the Department of Health and Human Services Centers for
15 Disease Control in support of a four-year proposal to prevent motor vehicle injuries
16 among the Tohono O'odham Nation members.
17 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH. Day
18 of OCTOBER, 2003 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0-
19 AGAINST; -0- NOT VOTING; and [08] ABSENT, pursuant to the powers vested in the Council by
20 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
21 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
22 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
23 Stat. 984).


