**(Amending Resolution No. 03-331 for the FY03 Sif-Oidak District Budget)**

**RESOLUTION NO. 03-488**

1 WHEREAS, the Sif-Oidak District FY 2004 Budget is pending further review by the Sif Oidak  
2 District Council; and

3 WHEREAS, in order for the District to continue its operations pending the approval and adoption  
4 of a budget, it is recommended that a continuing resolution be authorized for an  
5 additional three months; and


6 WHEREAS, the Tohono O'odham Legislative Council approved Resolution No. 03-331 to continue  
7 the FY03 Sif-Oidak District Budget; and

8 WHEREAS, the Sif Oidak District is requesting an additional month for final approval of its FY04  
9 Budget.


10 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby  
11 amend Resolution No. 03-331 for an additional extension of one month to November  
12 30, 2003.

13 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup>. Day  
14 of OCTOBER, 2003 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0-  
15 AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by  
16 Section 1 (d)(2)& (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the  
17 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
18 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
19 18, 1934 (48 Stat. 984).




