

11 of NOVEMBER, 2003 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0-  
12 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article  
13 II, Section 3 and Article IV, Section 1 (h) of the Constitution of the Tohono O'Odham Nation,  
14 adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy  
15 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act  
16 of June 18, 1934 (48 Stat. 984).
