RESOLUTION NO. <u>03-504</u>

1	WHEREAS, Resolution No. 03-409 mandated that only a six-month period budget would be
2	authorized based on status quo level of FY 2003; and
3	WHEREAS, Resolution No. 03-424 approved funding regular department and program
4	operations for a six-month period, therefore resulting in one-half of the funding
5	needs to expire on March 31, 2004.
6	WHEREAS, the Miss Tohono O'odham Nation promoters will need to utilize all funds in their FY
7	04 budget in response to the timing of the Miss Tohono O'odham activities.
8	NOW, THEREFORE, BE IT RESOLVED that a waiver of the six-month requirement be granted for the
9	Miss Tohono O'odham Nation budget, resulting in full funding of their FY 04 budget
10	upon the passing of this resolution.
11	The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the $04^{th}$ . Day
12	of NOVEMBER, 2003 at a meeting at which a quorum was present with a vote of 2,027.2 FOR; 602.5
13	AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by
14	Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
15	Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
16	Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
17	18, 1934 (48 Stat. 984).
