

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the San Xavier District Budget for the Fiscal Year beginning on
October 1, 2003 and ending on September 30, 2004)**

RESOLUTION NO. 03-505

1 **WHEREAS, the San Xavier District Council has reviewed the projected expenditures for the fiscal**
2 **year ending on September 30, 2004 and has determined that the budget components**
3 **are essential to meeting the needs of the San Xavier District Community; and**

4 **WHEREAS, the San Xavier District Council intends to utilize its gaming revenues to meet the**
5 **projected budget amount outlined in the attached fiscal year 2004 budget; and**

6 **WHEREAS, the San Xavier District intends to utilize funds due to the District from the Bureau of**
7 **Indian Affairs Tribal Trust Accounts to meet the projected amount outlined in the**
8 **attached fiscal year 2004 budget; and**

9 **WHEREAS, the proposed budget has been reviewed and approved by majority vote of the San**
10 **Xavier District members present at the Special District Community meeting held on**
11 **October 26, 2003; and**

12 **WHEREAS, the total proposed budget amount is \$4,621,968.32.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
14 **the San Xavier District fiscal year 2004 budget in the amount of \$4,621,968.32, and that**
15 **it shall be funded from the treasury of the San Xavier District.**

16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH Day**
17 **of NOVEMBER, 2003 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0-**
18 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section**
19 **1 (c)(8) & (i)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
20 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
21 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
22 **18, 1934 (48 Stat. 984).**






