

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(For an Enhancement Grant for the Venito Garcia Library and Archives from the Institute of Museum and Library Services, Native American Library Services)**

**RESOLUTION NO. 03-515**

1 **WHEREAS, WHEREAS,** the Tohono O'odham Legislative Council has historically supported the  
2 **Venito Garcia Library and Archives, the library agency for the Tohono O'odham**  
3 **Nation; and**

4 **WHEREAS, the Venito Garcia Library and Archives is charged with library development for the**  
5 **Tohono O'odham Nation;**

6 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council accepts the**  
7 **grant to the Venito Garcia Library and Archives from the Institute of Museum and**  
8 **Library Services, Native American Library Services for a two-year grant for the**  
9 **amount of \$143,250, and authorizes the use of \$ 71,625.00 of these funds for FY 2004**  
10 **by the Venito Garcia Library and Archives, and reserves \$ 71,625.00 of these funds to**  
11 **be re-authorized for FY 2005 for use during that year by the Venito Garcia Library and**  
12 **Archives..**

13 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05<sup>TH</sup> Day**  
14 **of NOVEMBER, 2003 at a meeting at which a quorum was present with a vote of 2,414.3 FOR; -0-**  
15 **AGAINST; -0- NOT VOTING; and 215.4 [06] ABSENT, pursuant to the powers vested in the Council by**  
16 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
17 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
18 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
19 **18, 1934 (48 Stat. 984).**
