

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the FY 2004 Hay Sale Revenue Budget in the amount of \$25,000)**

**RESOLUTION NO. 03-522**

1 **WHEREAS, the Livestock Facility Program is under the direction of the Natural Resources**  
2 **Department; and**

3 **WHEREAS, the Livestock Facility Program has been responsible for maintaining the use of the**  
4 **livestock facilities; and**

5 **WHEREAS, the Livestock Facility Program is seeking ways and means to establish the Livestock**  
6 **Complex to its original use; and**

7 **WHEREAS, the Livestock Facility Program is approved in Resolution #99-204 to expend funds in**  
8 **the revenue fund to pay the Tohono O'odham Farming Authority for the alfalfa hay**  
9 **sold; to fund the Livestock Yard Attendant; and to fund the service, maintenance and**  
10 **upgrade of the Livestock Complex and Complex equipment, account #44-1510; and**

11 **WHEREAS, the Livestock Facility Program has proposed a budget for the Hay Sales Program of**  
12 **\$25,000 for the fiscal year 2004 based on projected revenues; and**

13 **WHEREAS, the Livestock Facility Program will ensure that expenditures from the budget do not**  
14 **exceed actual revenues received.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
16 **the budget for the hay revenue account in accordance with the budget attached**  
17 **hereto provided that expenditures from the budget do not exceed actual revenues**  
18 **received.**

19 **BE IT FURTHER RESOLVED that expenditures by the program first provide for the purchase of hay**  
20 **for resale, repayment of the debt owed to the Tohono O'odham Farming Authority**  
21 **and then to the maintenance of the facility.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup>. Day**  
23 **of NOVEMBER, 2003 at a meeting at which a quorum was present with a vote of 2,155.4 FOR; -0-**  
24 **AGAINST; -0- NOT VOTING; and 474.3 [09] ABSENT, pursuant to the powers vested in the Council by**  
25 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
26 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
28 **18, 1934 (48 Stat. 984).**
