

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2004 Pen/Lease Budget in the amount of \$1,200.00)

RESOLUTION NO. 03-523

1 **WHEREAS, the Livestock Facility Program is under the direction of the Natural Resources**
2 **Department; and**

3 **WHEREAS, the Livestock Facility Program has been responsible for maintaining the use of the**
4 **facilities; and**

5 **WHEREAS, the Livestock Facility is seeking ways and means to establish the Livestock Complex**
6 **to its original use; and**

7 **WHEREAS, the Livestock Facility Program is approved in Resolution #2000-39 for a special**
8 **account for the revenue deposits from pen proceeds. Account #44-1519-450; and**

9 **WHEREAS, the Livestock Facility Program has proposed a pen lease revenue budget for fiscal**
10 **year 2004 in the amount of \$1200; and**

11 **WHEREAS, the Livestock Facility Program has a projected pen lease revenue of \$5,400 for fiscal**
12 **year 2004; and**

13 **WHEREAS, the Livestock Facility Program will use pen proceeds to purchase supplies and**
14 **materials to maintain the facility and improve services to the livestock owners of the**
15 **Nation.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
17 **the budget for utilizing the pen proceeds for maintaining the facility and improving**
18 **services to the livestock owners of the Nation.**

19 **BE IT FURTHER RESOLVED that the Livestock Facility Program will utilize only revenues collected**
20 **and will maintain a positive balance in the Pen/Lease account at all times.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH. Day**
22 **of NOVEMBER, 2003 at a meeting at which a quorum was present with a vote of 2,155.4 FOR; -0-**
23 **AGAINST; -0- NOT VOTING; and 474.3 [08] ABSENT, pursuant to the powers vested in the Council by**
24 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
25 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
27 **18, 1934 (48 Stat. 984).**


