12 **a proposed budget in the amount of \$2,515,927.32 to cover anticipated cost and**
13 **expenditure for FY 2004; and**

14 **WHEREAS, a public meeting was scheduled on November 3rd to provide community members**
15 **an opportunity to comment on the proposed budget, thereafter on November 4th the**
16 **San Lucy District Council enacted Resolution No. SL 11-148-03, "Approving the FY**
17 **2004 San Lucy District Budget in the amount of \$2,515,927.32; and**

18 **WHEREAS, on November 5th the Tohono O'odham Legislative Council's Budget & Finance**
19 **Committee reviewed the San Lucy District FY 2004 and recommended that said**
20 **budget be presented to the Tohono O'odham Legislative Council.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
22 **approves the San Lucy District FY 2004 Budget in the amount of \$2,515,927.32**
23 **retroactive to October 1, 2003.**

9 **18, 1934 (48 Stat. 984).**


