

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2004 Budget for the HICKIWAN District in the amount \$624,491.73)

RESOLUTION NO. 03-525

1 **WHEREAS, the HICKIWAN District Council held a special meeting on the FY 2003 Budget on**
2 **October 27, 2003; and**

3 **WHEREAS, the Tohono O'odham Nation allocated funds to the 11 Districts from Gaming**
4 **Revenues; and**

5 **WHEREAS, the HICKIWAN District received \$461,272.43 from the Gaming Revenue; and**

6 **WHEREAS, the HICKIWAN District maintains accounts held in the Wachovia Securities, where**
7 **these funds will be maintained on behalf of the HICKIWAN District; and**

8 **WHEREAS, the District Council has held numerous meetings to discuss the FY 2004 Budget of the**
9 **HICKIWAN District; and**

10 **WHEREAS, the HICKIWAN District also held numerous meetings to discuss looking into the**
11 **investments held with Wachovia Securities to maintain and cover its FY 2004 budget;**
12 **and**

13 **WHEREAS, the HICKIWAN District is in support and approves the FY 2004 Budget in the amount**
14 **of \$461,272.43 and the investments of Wachovia Securities in the amount of**
15 **\$163,219.30 to cover the FY 2004 budget; and**

16 **WHEREAS, the District Council urges the Tohono O'odham Legislative Council to approve the FY**
17 **2004 Budget for the HICKIWAN District.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
19 **the FY 2004 budget of the HICKIWAN District in the amount of \$461,272.43 which will**
20 **be held in the Wachovia Securities Account for the HICKIWAN District and approval of**
21 **using the HICKIWAN District's investment money in the amount of \$163,219.30 to cover**
22 **the FY 2004 budget in the total amount of \$624,491.73.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH Day**
24 **of NOVEMBER, 2003 at a meeting at which a quorum was present with a vote of 2,248.0 FOR; -0-**
25 **AGAINST; 166.3 NOT VOTING; and 215.4 [05] ABSENT, pursuant to the powers vested in the Council**
26 **by Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**
27 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
29 **18, 1934 (48 Stat. 984).**
