(Authorizing Tohono O'odham Nation Delegation to the National Congress of American
Indians 60th Annual Session)**

RESOLUTION NO. 03-531

1 **WHEREAS, the National Congress of American Indians (NCAI) will hold its 60th Annual Session in**
2 **Albuquerque, New Mexico on November 16 - 21, 2003; and**

3 **WHEREAS, the Tohono O'odham Nation is a longtime member in good standing with the National**
4 **Congress of American Indians; and**

5 **WHEREAS, it is in the best interest of the Tohono O'odham Nation to renew its membership in the**
6 **National Congress of American Indians.**

7 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
8 **authorizes the following members to attend and serve as the Tohono O'odham**
9 **Nation's Delegation to the National Congress of American Indians 60th Annual**

22 **Chairwoman Vivian Juan-Saunders as the Tohono O'odham Nation's voting delegate**
23 **and Vice Chairman Ned Norris, Jr. as alternate voting delegate to the National**
24 **Congress of American Indians 60th Annual Session.**

25 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes**
26 **payment of NCAI membership dues for the Tohono O'odham Nation in the amount of**
27 **\$5,000 from the Legislative Branch dues and subscriptions line item.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH. Day**
29 **of NOVEMBER, 2003 at a meeting at which a quorum was present with a vote of 2,370.8 FOR; -0-**
30 **AGAINST; -0- NOT VOTING; and 258.9 [05] ABSENT, pursuant to the powers vested in the Council by**
31 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
32 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
34 **18, 1934 (48 Stat. 984).**
