

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Amendment to Resolution No. 03-436, Approving FY 2004 Bureau of Indian Affairs**  
**Budgets and Annual Funding Agreement Under P.L. 93-638 Master Contract,**  
**Correcting amounts for Judicial Services)**

RESOLUTION NO. 03-532

1 WHEREAS, the Tohono O'odham Legislative Council in Resolution No. 03-436 approved the FY  
2 2004 Bureau of Indian Affairs Budgets and Annual Funding Agreement Under P.L. 93-  
3 638 Master Contract for various programs in the amount of \$11,414,212.27 in Direct  
4 Funds and Estimated IDC \$1,347,693.47 = \$12,761,905.74; and

5 WHEREAS, the initial amount approved for Judicial Services requires amendment to include  
6 carry over savings of \$182,100.16, consisting of \$112,595.31 accumulated savings  
7 from prior years and \$69,504.85 estimated savings from FY-2003 as stated in  
8 attached budget and hereby amend to state as follows:

9 F. Judicial Services - \$473,118.16 + \$78,175.73 (Estimated IDC) for a total of  
10 \$551,293.89.

11 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby  
12 approve the amendment to Resolution No. 03-436 for the Judicial Services budget to  
13 include carry over savings of \$182,100.16 and amend the Total amount of budgets to  
14 state Direct \$11,596,312.46 and Estimated IDC \$1,378,104.24 = \$12,974,416.66.

15 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup>. Day  
16 of NOVEMBER, 2003 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0-  
17 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by  
18 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the  
19 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
20 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
21 18, 1934 (48 Stat. 984).


