

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving an Attorney Contract with Robert R. Yoder)**

**RESOLUTION NO. 03-539**

1 **WHEREAS, by Resolution No. 02-575, the Tohono O'odham Legislative Council approved an**  
2 **Attorney Contract with the law firm of Robert R. Yoder, P.C. for legal services related**  
3 **to the Tohono O'odham Nation 401 (k) Plan for fiscal year 2003; and**

4 **WHEREAS, the Attorney Contract expired on September 30, 2003; and**

5 **WHEREAS, the sum of \$2,500 is required for legal fees and expenses to assure uninterrupted**  
6 **legal representation for the six-month period ending March 31, 2004; and**

7 **WHEREAS, sufficient funds have been budgeted in the 401 (k) Trustee budget to fund the Attorney**  
8 **Contract in such amount; and**

9 **WHEREAS, the Domestic Affairs and Budget & Finance Committees recommend approval of the**  
10 **Attorney Contract for the six-month period ending March 31, 2004 in the amount of**  
11 **\$2,500.**

12 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 13 **1. The Tohono O'odham Legislative Council approves an Attorney Contract with the**  
14 **law firm of Robert R. Yoder, P.C. in the amount of \$2,500 for the six-month period**  
15 **ending March 31, 2004, and in the form attached hereto.**
- 16 **2. Funding for the Attorney Contract shall be provided from the 401(k) Trustee**  
17 **budget (Account No. 01-3036-810).**
- 18 **3. The Chairwoman of the Nation is authorized and directed to execute the Attorney**  
19 **Contract.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 01<sup>ST</sup> Day**  
21 **of DECEMBER, 2003 at a meeting at which a quorum was present with a vote of 2,438.3 FOR; -0-**  
22 **AGAINST; -0- NOT VOTING; and 191.4 [03] ABSENT, pursuant to the powers vested in the Council by**  
23 **Section 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
24 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
26 **18, 1934 (48 Stat. 984).**
