

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Attorney Contract with Rolando Ballesteros Navarro Related to
Economic Development Services in Mexico)

RESOLUTION NO. 03-541

1 WHEREAS, the Tohono O'odham Legislative Council approved the plans of the Economic
2 Development Department (the "Department") to deliver services to members of the
3 Nation living in Mexico in FY 2000 by means of Resolution 2000-150 and in FY 2001 by
4 means of Resolution 2000-447; and

5 WHEREAS, the Legislative Council also approved FY 2004 budget for the Department related to
6 the Department's administration of the business grant program and other activities
7 in Mexico (Account 24-1813); and

8 WHEREAS, the Department, the Attorney General, grantees and grant applicants, and the
9 Executive Office require advice on the laws applicable to grantee businesses and
10 Department activities in the United States and Mexico; and

11 WHEREAS, the budget of the Department respectively includes funds to engage an attorney for
12 that purpose (24-1813.810); and

13 WHEREAS, the Department recommends continuing the representation of Rolando Ballesteros
14 Navarro for program matters related to Mexico; and

15 WHEREAS, an Attorney Contract with Rolando Ballesteros Navarro in the amount of \$60,000,
16 copies of which have been prepared and are attached hereto.

17 NOW, THEREFORE, BE IT RESOLVED THAT:

- 18 1. The Legislative Council approves, in the form attached hereto, an Attorney
19 Contract with Rolando Ballesteros Navarro in the amount of \$60,000 for fiscal
20 year 2004 and payable from the fiscal year 2004 budget of the Economic
21 Development Department (Account 24-1813.810).
- 22 2. The Chairwoman of the Nation is authorized and directed to execute the
23 foregoing Attorney Contract.

24 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 01ST Day
25 of DECEMBER, 2003 at a meeting at which a quorum was present with a vote of 1,360.2 FOR; 1,078.1
26 AGAINST; -0- NOT VOTING; and 191.4 [04] ABSENT, pursuant to the powers vested in the Council by
27 Section 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
28 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
29 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
30 18, 1934 (48 Stat. 984).
