

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Attorney Contract with the Law Firm of Sacks Tierney Related to
Initiative Business Grants)**

RESOLUTION NO. 03-542

1 WHEREAS, the Tohono O'odham Legislative Council appropriated \$15 million for business
2 grants to enrolled members of the Tohono O'odham Nation, as authorized in an
3 Initiative (IN-01-97) passed by voters of the Nation; and

4 WHEREAS, the Legislative Council has approved the budget for the Economic Development
5 Department (the "Department") related to the Department's administration of the
6 grant program; and

7 WHEREAS, the Department, grantees and grant applicants, and the Executive Office require
8 advice on the laws applicable to grantee businesses situated within the United
9 States; and

10 WHEREAS, the approved budget of the Department includes funds to engage attorneys for that
11 purpose (24-1805.810); and

12 WHEREAS, the Department recommends the continuing representation of the law firm of
13 Sacks Tierney; and

14 WHEREAS, an Attorney Contract with Sacks Tierney in the amount of \$30,000 has been prepared,
15 copies of which are attached hereto; and


16 WHEREAS, the Domestic Affairs, Commerce and Budget & Finance Committees recommend
17 approval of the Attorney Contract.

18 NOW, THEREFORE, BE IT RESOLVED THAT:

- 19 1. The Tohono O'odham Legislative Council hereby approves, in the form attached
20 hereto, an Attorney Contract with the law firm of Sacks Tierney in the amount of
21 \$30,000 for fiscal year 2004 and payable from the fiscal year 2004 budget of the
22 Economic Development Department (Account No. 24-1805.810).
- 23 2. The Chairwoman of the Nation is authorized and directed to execute the
24 foregoing Attorney Contract.

25 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 01ST Day
26 of DECEMBER, 2003 at a meeting at which a quorum was present with a vote of 2,162.55 FOR; 192.6
27 AGAINST; 83.15 NOT VOTING; and 191.4 [03] ABSENT, pursuant to the powers vested in the Council
28 by Section 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
29 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
30 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
31 18, 1934 (48 Stat. 984).
