

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Attorney Contract with the Law Firm of DeConcini McDonald Yetwin & Lacy)

RESOLUTION NO. 03-551

1 **WHEREAS, pursuant to Resolution No. 2000-275, the Tohono O'odham Legislative Council**
2 **appropriated \$15,191,080 to be used for the design, construction, staffing and**
3 **operations of the Cultural Center/Museum; and**

4 **WHEREAS, the Cultural Affairs Program requires legal representation to prepare requests for**
5 **proposals and the related architectural services agreement and construction**
6 **contract; and**

7 **WHEREAS, the Cultural Affairs Program recommends the engagement of the law firm of**
8 **DeConcini McDonald Yetwin & Lacy (the "Attorneys") for the foregoing legal services;**
9 **and**

10 **WHEREAS, attached hereto is an Attorney Contract with the Attorneys in the amount of \$25,000**
11 **for fiscal year 2004; and**

12 **WHEREAS, the Cultural Preservation, Domestic Affairs and Budget & Finance Committees**
13 **recommend approval of the Attorney Contract.**

14 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 15 **1. The Tohono O'odham Legislative Council hereby approves an Attorney**
16 **Contract with the law firm of DeConcini McDonald Yetwin & Lacy in the**
17 **amount of \$25,000 for fiscal year 2004, and in the form attached hereto.**
- 18 **2. Funding for the Attorney Contract shall be provided from the Cultural**
19 **Affairs/Museum Budget (Account No. 50-1516-810).**
- 20 **3. The Chairwoman of the Nation is authorized and directed to execute the**
21 **Attorney Contract.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03RD. Day**
23 **of DECEMBER, 2003 at a meeting at which a quorum was present with a vote of 2,544.55 FOR; -0-**
24 **AGAINST; 85.15 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
25 **Section 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
26 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
28 **18, 1934 (48 Stat. 984).**
