1 **WHEREAS, the Planning Department's Transportation Program applied for and received grant**  
2 **funding in the amount of \$25,000.00; and**

3 **WHEREAS, this project is funded by a Pima Association of Governments (PAG) grant to enhance**  
4 **community pride by involving District youth in designing public transportation art;**  
5 **and**

6 **WHEREAS, the Planning Department is requesting approval and acceptance of the funds in the**  
7 **amount of \$25,000.00; and**

8 **WHEREAS, the grant will be administered by the Planning Department's Transportation**  
9 **Program.**

10 **NOW, THEREFORE, BE IT RESOLVED the Tohono O'odham Legislative Council hereby accepts the**  
11 **fund amount of \$25,000.00 and approves the attached budget and request that an**  
12 **account be established by Grants and Contracts.**

13 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03<sup>RD</sup> Day**  
14 **of DECEMBER, 2003 at a meeting at which a quorum was present with a vote of 2,414.3 FOR; -0-**  
15 **AGAINST; -0- NOT VOTING; and 215.4 [03] ABSENT, pursuant to the powers vested in the Council by**  
16 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
17 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
18 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
19 **18, 1934 (48 Stat. 984).**


