

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Cancel Special Session set for December 11 & 12, 2003 For Enrollment Rejection Hearings)**

**LEGISLATIVE ORDER NO. 03-555**

1 **WHEREAS, pursuant to Legislative Rules, Article I, Section 1(D)(1), the Legislative Council by**  
2 **majority vote, called for Special Sessions to be held for the purpose of conducting**  
3 **Enrollment Rejection Hearings; and**

4 **WHEREAS, pursuant to Legislative Order No. 03-388 the special sessions are set for December 11**  
5 **& 12, 2003 to conduct Enrollment Rejection Hearings pursuant to Article VIII, 1 (B) of**  
6 **the Enrollment Ordinance; and**


7 **WHEREAS, it was recently discovered that the majority of the current Enrollment Committee**  
8 **members are not appointed as required, pursuant to Article II, Section 1(B) of the**  
9 **Enrollment Ordinance as amended by Legislative Council Resolution No. 91-514 (copy**  
10 **attached); and**

11 **WHEREAS, the Rules Committee of the Legislative Council requests that the special sessions now**  
12 **set for December 11 & 12, 2003 be cancelled.**

13 **NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council hereby cancels**  
14 **the Special Sessions now set for December 11 & 12, 2003.**

15 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 03<sup>RD</sup>. Day of**  
16 **DECEMBER, 2003 at a meeting at which a quorum was present with a vote of 2,447.65 FOR; 182.05**  
17 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
18 **Section 1 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
19 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
20 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
21 **18, 1934 (48 Stat. 984).**
