1	WHEREAS,	by Resolution No. 94-098, the Legislative Council adopted the Gaming Revenue
2		Distribution Formula to allocate the revenue paid to the Nation by the Tohono
3		O'odhamGamingAuthoritypursuanttoSection7(d)oftheGamingAuthorityCharter;

5	WHEREAS,	by Legislative Order No. 03-027, the Legislative Council tabled for twelve months
6		consideration of a modification of the Gaming Revenue Distribution Formula; and
7	WHEREAS,	it is in the Nation's interest to modify the Gaming Revenue Distribution Formula to
8		better meet the current and projected financial needs for its members.
9	NOW, THER	EFORE, BE IT RESOLVED THAT:
10		1. Resolution No. 94-098 is amended as follows:
11		(a) The first word of \P 1(a) is amended from <i>Fifty</i> to <i>Thirty</i> ;
12		(b) The parenthetical following the second word of \P 1(a) is amended from
13		(50%) to (30%);
14		(c) The third word of ¶ 1(b) is amended from fifty to seventy;
15		(d) The parenthetical following the fourth word of \P 1(b) is amended from
16		(50%) to (70%).
17	3	${\bf 2.} \qquad \textbf{All other terms of Resolution No. 94-098 not inconsistent with the above-stated}$
18		modifications shall remain effective.
19		${\bf 3.} \qquad {\bf The Executive Office in conjunction with the Commerce and Budget \& Finance}$
20		Committees shall be directed to formulate a report of recommendations
21		within 60 days of the effective date of the Legislative Council Resolution. This
22		report shall include specific criteria and guidelines for administering and
23		utilizing the funds in the account established pursuant to \P 1(a) of Resolution
24		No. 94-098 (the Gaming Revenue savings account, currently known as the
25		Desert Diamond Savings Trust Account). The report of recommendations shall
26		be submitted to the Chairperson of the Nation, the Chairperson of the
27		Legislative Council, the Chief Judge of the Tohono O'odham Judiciary and to the
28		Chairperson of each of the Nation's Districts. Any recommendations must be
29		adopted by action of the Legislative Council before becoming effective. Other

than what has already been approved by the Legislative Council, no additional
