16		and safeguarding our future, ensuring the safety of our tribal members, creation of			
17		an International Affairs Office, and developing a Constitutional Review Committee;

20		Council, and the public for input.			
21	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby
